PROJECT PROGRESS APRIL 2017 TO APRIL 2018:

The Lower Platte South Natural Resources District (LPSNRD) Airborne Electromagnetic Survey (AEM) flights were flown between July 27, 2016 and August 2, 2016 over the eastern portion of the District and reported on the previous WSF 2017 Annual Report for the above-referenced project. The final LPSNRD AEM results report from Aqua-Geo Frameworks, LLC (AGF) was received by LPSNRD on November 10, 2017. The final report summarized the AEM survey results and incorporated the results with existing cross section and Conservation and Survey Division (CSD) test-hole data, GIS spatial data, and NDNR registered well data (select logs of registered wells will be used for general reference and comparisons). The report included the following results:

- Appendix 1 LPSNRD AEM Flight Line 2D Profiles in pdf format
- Appendix 2 LPSNRD AEM 3D Fence Diagrams and Voxel Images in pdf format
- Interactive Google Earth datasets and 164 associated interpreted profile images

ANTICIPATED ACTIVITIES FROM NOW UNTIL NEXT ANNUAL REPORT DUE APRIL 1, 2019:

The report results are scheduled for presentation by AGF at the Lower Platte South NRD on April 4, 2018. Once the LPSNRD board approves the report, the pdf and Google Earth datasets will be publically available from http://enwra.org/aem2016.html (posted online through the Lower Platte South NRD hotlink at the top of the page). The LPSNRD anticipates submitting the final status report to the Department for WSF #4132 following the April 2018 results presentation, likely issuance in the month of May 2018.


ANTICIPATED CASH FLOW FOR REMAINDER OF THE PROJECT:
