# **DNR UPDATE & PUBLIC COMMENTS**

Director Riley offered updates on the following:

- DNR has a bill to remove filing fee requirements because it costs more to process a fee than the fee generates in revenue.
- The governor's budget proposes to remove the Water Sustainability Fund appropriation awarded to the Cedar-Knox project in 2022 and the associated spending authority.
- \$85 million of the JEDI funding that was previously allocated for the I-80 lake project is proposed to go away.

- The Governor's budget also proposes that DNR will receive a rebate for Information Technology costs associated with OCIO services as well as a proposed budget reduction in the same amount for future work.
- DNR is fully staffed, there are a few retirements in the works.
- The design work of the Perkins County Canal is about 10% complete and working towards being 30% complete by the end of next year including the layout of the final route.
- Bob Robles, DNR Deputy Director, was introduced. Robles takes care of Finance and Human Resources at DNR and will be assuming some of Jill Richters' duties when she retires in May.

No additional comments were offered from people in the audience.

# **EXECUTIVE COMMITTEE**

#### WSF Guidelines Update

Prior to the meeting, a revised Water Sustainability Fund Guidelines draft was emailed to commissioners with redline changes showing updates matching those pending revisions to WSF Rules T-261. After discussing the updates, no additional changes were offered. Revised guidelines will be posted on the NRC's website once pending updates to the rules go into effect. Batie requested Commissioners email any additional suggestions for revisions to the guidelines.

# T-261 Rules Change Certification of Adoption

Chairman Batie announced that following a public hearing on January 18<sup>th</sup>, 2024, the Executive Committee took an action on January 26<sup>th</sup>, 2024, to adopt the Rules Governing the Administration of the Water Sustainability Fund. This action was taken in accordance with the Commission's November 28<sup>th</sup>, 2023, motion to proceed, for the purpose of moving forward with the formal rules change process in order to allow these changes to be effective for the next round of application reviews. Chairman Batie, on behalf of the Commission, signed the Certificate of Adoption and forwarded the packet to the Attorney General's Office for review. The Attorney General has signed off on the proposed updates and forwarded the packet to Governor Pillen for signature. Once approved, the updated rules will take effect immediately.

# COMPREHENSIVE PLANNING COMMITTEE

Chairman Reynolds offered no additional updates.

# **LEGISLATIVE COMMITTEE**

Chairman Smathers offered no additional updates.

#### PROGRAM COMMITTEE

No updates were given. Chairman Kubat asked staff to lead discussion on agenda topics pertaining to program activities. No unusual activity was reported.

#### **Resources Development Fund**

The status report showed business as usual.

#### **Small Watersheds Flood Control Fund**

This is currently an unfunded program.

#### Soil & Water Conservation Program Fund

The status report showed business as usual. Letters will be going out to NRD managers asking if they have unobligated funds.

#### **Natural Resources Water Quality Fund**

The status report showed business as usual. A distribution just went out.

# Water Well Decommissioning Fund

The status report showed business as usual.

#### Water Sustainability Fund

The status report showed business as usual. Staff also reviewed a closed projects report that had been requested by Chairman Batie for Commissioner's use and background knowledge describing project that have been successfully completed that were funded by WSF. Seven additional projects were noted as being ready for formal closeout during the August NRC meeting.

#### WSF #5209 Project Review

Russ Callan, LLNRD; Jason Moudry, LLNRD; and Dan Bigbee, EA Engineering, appeared and gave an overview of their recently completed Cover Crop Impact Study (WSF #5209). The study looked at the effects of growing a second crop on the water budget regarding overall consumption and recharge. The study took place during the 20-21, 21-22 & 22-23 growing seasons which included a very wet year, a very dry year and a year with average rainfall. The study sites were all irrigated. Looking at each site independently on an annual basis, there was no statistical difference on potential recharge between cover crop and no cover crop at two sites, but there was a statistical difference on the third site. Looking at the combined data for all three sites over the entire three-year period, there was no statistical difference between the cover crop and no cover crop on groundwater recharge potential.

Geographically, this study was very finite with a very tight coverage location. Callan pointed out this study may have been located close to a rainfall divide where cover crops to the east receive more rainfall and to the west less which could also have an effect on recharge potential. Cover Crop management decisions could also affect recharge potential. Overall, the results showed either no effect or a slightly positive effect to groundwater recharge by adding cover crops.

Bigbee concluded that the study gives NRDs that cost share and promote the use of cover crops a little confidence, to the extent that there was not a glaring net water loss and that there is a slight positive effect under some conditions. Now there is a data point in this particular area for these particular fields under these cropping patterns. Under those parameters, the use of cover crops is not contributing to groundwater depletion.

# **OTHER BUSINESS**

- Jill Richters announced that she will be retiring on May 3<sup>rd</sup>.
