LENRD Request to Modify Practice NC-12 (H)

Curt Becker, Assistant Manager of the Lower Elkhorn Natural Resources District (LENRD), stated that the current practice does not allow for cost share on fabric weed barrier and drip irrigation system at the same time. LENRD is asking the NRC to allow NSWCP cost share for the use of both practices on a project. These two practices, when used in conjunction, give trees the best survivability rate.

Batic noted that this will be available to all NRDs if approved.

Reynolds moved and Smathers seconded the motion modify NSWCP Practice NC-12 (H), to allow funding to be used for both drip irrigation systems and fabric weed barrier on windbreak projects rather than limiting cost-share to one or the other.

CKRWP WSF #10035 Update

Staff reported the Legislature swept funding that the Commission allocated to this project (\$8,481,000.00) and made it illegal to fund a project fitting the description of the Cedar-Knox Rural Water Project. In the records, the Legislature allocated this funding to the Water Sustainability Fund in 2022, the NRC allocated funding to this project in 2022 and fully obligated funding to this project

between 2022 & 2023. No reimbursements were made, and the funding is gone (as shown below in the WSF Project Close Outs & Grant Reductions, 2024 table).

APPLICATIONS REVIEW COMMITTEE

Committee Chairman Steinkruger noted the Committee met via zoom on July 8th and in person July 22nd & 23rd, in Kearney. Commissioners were provided with a zip drive containing a scoring sheet and the applications and were asked to review and score each application. Commissioners received a

packet, prior to this meeting, containing the committee recommendations for scores, conditions and a listing of the scoring questions. Commissioners were also provided a proposed funding distribution breakout.

Steinkruger reviewed each application in the small funding request category starting with the highest scoring application, then reviewed those in the large project funding request category. It was noted that the Santee application received two bonus points as a way of addressing the legislative intent this type of project be given preference.

Steinkruger moved and Brundage seconded the motion to approve the Application Review Committee's recommended scores and fund all Large Project applications with a score of 49 or higher subject to the conditions proposed by the Application Review Committee, limiting the obligation for WSF #10093 to all remaining funding \$59,868.33 in accordance with Title 261 Chapter 3 Subsection 002.03 and Neb. Rev. Stat. § 2-1507 (4). The allocation for WSF #10093 is \$360,000.00, the obligation is \$59,868.33, and the remaining unobligated balance is \$300,131.67.

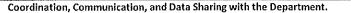

Contract Provisions:

F



- A Throughout the Project timeline, Sponsor shall coordinate and communicate with the Department on the Project's compatibility with water management goals, objectives, and action items resulting from the joint planning efforts between Sponsor and the Department.
 - i. Within sixty (60) days following the execution of this Agreement, Sponsor and Department shall meet to further mutually define the scope of this coordination and communication requirement.
- B Sponsor shall share with the Department all data and models that are generated as a result of this Project in a form that includes documentation and metadata and that is mutually agreed upon by Sponsor and Department.
- Prior to entering into an agreement with the DNR for fund disbursement, sponsor must agree to limit reimbursement for administration and project management expenses to those performed by parties other than the sponsor and its partners.
- Prior to entering into an agreement with DNR for fund disbursement, sponsor must certify that it has all necessary land rights to underdo the project and that a complete listing of all lands involved in the project along with proof of ownership will be provided if requested by the Department.
- Prior to entering into an agreement with ONR for fund disbursement, sponsor must complete and submit a financial disclosure statement showing proof of ability to pay its 40% local share match; and certify that it has all local share funding necessary to complete the project.
 - Cost share for land rights including easement purchases is limited to lands within the State of Nebraska. Costs associated with land rights outside of the State of Nebraska will not be used in cost share calculations.
