#### **DNR UPDATE & PUBLIC COMMENTS**

The Nitrogen Reduction Incentive Act (LB 1368) Guidance Document is nearly complete, and the program will start taking applications for the 2025 growing season in a few weeks. Incentive payments for reducing nitrogen application by the lesser of 15 pounds or 15% from baseline application rates will be made through NRDs targeting Priority Areas of elevated nitrate levels. Of the \$1 million dollars available for incentive payments, half will be evenly distributed between NRDs with the other half distributed by NRDs based upon the number of acres in wellhead protection areas and areas designated by NRDs in phase II or higher water quality

management areas. The program is designed to be flexible enough to move funding from NRDs with low participation demand to those with demand exceeding available funding.

No additional comments were offered from people in the audience.

#### **PROGRAM COMMITTEE**

Staff lead discussion on agenda topics pertaining to program activities. No unusual activity was reported.

#### **Resources Development Fund**

The status report showed business as usual. Reynolds mentioned the contract for the Prairie Silver Moores education building is signed, the contractual completion date is December of 2025, and the contractor has already started moving dirt.

#### **Small Watersheds Flood Control Fund**

This is currently an unfunded program.

#### Soil & Water Conservation Program Fund

The status report showed business as usual.

### **Natural Resources Water Quality Fund**

The status report showed business as usual.

#### **Water Well Decommissioning Fund**

The status report showed business as usual.

#### **Water Sustainability Fund**

The status report showed business as usual. Staff and Commissioners discussed the status of most projects. Chairman Batie encouraged Commissioners to keep in contact with your Senators and those that are on NRD boards to encourage your managers to apply for WSF grants. Batie noted issues surrounding aging infrastructure of dams and the nitrate issues as possibilities for projects.

- The next NRC meeting is scheduled for February 19<sup>th</sup>, 2025. One of the agenda items will be election of officers. Batie will appoint three members to the Nominating Committee.
