DNR UPDATE & PUBLIC COMMENTS

Director Bradley is in the process of aligning staff skills and abilities with workload needs to make the combined agency function efficiently. Commissioner Meyer,

mentioned the Perkins County Canal lawsuit has been filed with the Supreme Court and that she and her law firm will be involved in that litigation.

Obligation #10093

Batie noted this project had been approved (Fully Allocated) last year but only partially funded (Obligated) due to funding limitations.

APPLICATIONS REVIEW COMMITTEE

Committee Chairman Brundage noted the Department forwarded all 22 applications (except Omaha's CSO application) for review and scoring. The Committee met on July 8th and 9th to review each application and run through the scoring process. The Committee produced a recommendation for scores, funding conditions, ranking and funding. That recommendation was sent to Commissioners prior to this meeting.

Brundage called upon staff to describe the funding situation. Staff stated that there was no legislative appropriation to the WSF for FY 26; \$8 million was transferred from the Nebraska Environmental Trust subject to funding being expended for projects meeting the funding purposes of the NET. Because there was no legislative appropriation, there was no additional funding authority. There exists within the WSF, \$1,821,920.32 of previously unused spending authority. Therefore, the Commission is limited to awarding no more than \$1,821,920.32 this year. The Department intends to pursue acquiring additional funding authority during the next legislative session to allow the Commission to use the remaining funding for the 2026 WSF application cycle. Batie noted the Omaha CSO project receives 10% of the WSF appropriation each year and therefore it will not receive funding this year as 10% of zero is zero.

Brundage reviewed the process the committee went through during the Committee meeting to reach a final recommendation for scores, conditions, ranking and a funding decision for each application. Brundage stated the combined total funding requested by the 22 applications exceeded \$24 million.

Brundage reviewed the scoring range for both large and small funding categories and stated the Committee spent a lot of time looking at available funding and scores. The Committee concluded there is a break between scores after the top two in each category and there was sufficient funding to fully fund these four projects. Therefore, the Committee recommended funding the two highest scoring projects in each category. Brundage then reviewed all four applications and staff reviewed the funding amount each had requested. Batie stated there were more projects that were worthy of being funded if there would have been funding available. Rexroth stated it is important to talk to senators about spending authority as well as to revisit the funding level.

Shadle asked staff to explain funding authority and the issues with it this year. Zimmerman replied that a legislative appropriation is spending authority, but there is no cash tied to that. The actual money comes through a cash transfer in the budget bill which is a separate legislative item. There is also reappropriation which allows the fund balance at the end of the fiscal year to be moved into the next fiscal year. This year the legislature appropriated \$0.00 to this fund; transferred \$8,000,000 from NET to WSF through a cash transfer; and allowed reappropriation of the balance remaining in the fund.

Clint Verner, Legislative Fiscal Office explained that the reason why the legislature did not give spending authority for the NET funds was that if the appropriation was granted, the Omaha CSO project would have had to be funded with NET money which would have created a project conflict at NET by opening a can of worms in that sewer projects would then be eligible for Environmental Trust funding. The legislature didn't want to go down that road. With the

transfer of the \$8 million, they wanted to fund the outstanding obligation (WSF #10093). It was too late in the budget cycle to draft additional legislation, so rather than go into natural resources law which is outside of the Appropriation Committee's jurisdiction, they decided they would decide how to handle this appropriation issue next year.

Brundage noted that along with the "2025 NRC Application Review Committee's Recommended Scores" sheet that was handed out, there was also a contract provisions sheet "Application Review Committee's Recommendation for Conditions of Approval" and a packet of "WSF Application Conditions" (all attached).

Staff noted that by statute, any projects approved for funding must be in line with the purposes of the NET. Batie noted that during the application review committee meeting he had pulled up the NET statutes and rules and it was clear to the committee that all of the applications they had reviewed met that qualification. Brundage noted the NET statute was Neb. Rev. Stat. Section 81-15, 168, and that WSF #10093 was in line with that statute also.

- A. Throughout the Project timeline, Sponsor shall coordinate and communicate with the Department on the Project's compatibility with water management goals, objectives, and action items resulting from the joint planning efforts between Sponsor and the Department.
- B. Sponsor shall share with the Department all data that is generated as a result of this Project in a form that includes documentation and metadata and that is mutually agreed upon by Sponsor and Department.

B. The following condition applies to application(s) No.

➤ **Coordination, Communication, and Data Sharing with the Department.**

- A. Throughout the Project timeline, Sponsor shall coordinate and communicate with the Department on the Project's compatibility with water management goals, objectives, and action items resulting from the joint planning efforts between Sponsor and the Department.
 - i. Within sixty (60) days following the execution of this Agreement, Sponsor and Department shall meet to further mutually define the scope of this coordination and communication requirement.
- B. Sponsor shall share with the Department all data that is generated as a result of this Project in a form that includes documentation and metadata and that is mutually agreed upon by Sponsor and Department.

- Prior to entering into an agreement with Department for fund disbursement, sponsor must certify that it has all necessary land rights to underdo the project and that a complete listing of all lands involved in the project along with proof of ownership will be provided if requested by the Department.
