## Project Overview: April 2024 – April 2025

The Nebraska Association of Resources Districts (NARD) continued development and deployment of *Producer Connect*, a collaborative digital tool designed to empower agricultural producers with the tools they need to optimize inputs, enhance agricultural profitability, improve water quality, and increase irrigation efficiency.

- March 5, 2025: *Producer Connect* demo at the NRD Managers Meeting.
