MINUTES

EXPENDITURES

The expenditures report for the various funds for the months of November and December 2006 had been distributed to Commission members. Extra copies were available.

ADVISOR'S COMMENTS

Steve Chick, NRCS State Conservationist, distributed a report and briefed the Commission on programs and achievements. Comments are summarized below and more detail was available in the report:

- Budget Update NRCS is still operating under a continuing resolution (CR) until February 15 which includes about \$2.5 million less for Nebraska than from last year.
- Central Basin CREP Sign-up started on January 22 for this program which is a rejuvenation of the old project. Emphasis is on buffer strips and riparian strips and some of the incentives have been increased to encourage participation.
- EQIP Sign up for the 2007 EQIP program which includes a number of special initiatives will end on January 31. One of the initiatives, the Tri-Basin Conservation Corners Program, is a special initiative developed by the Tri-Basin NRD with a number of other partners for converting from irrigated pivot corners to wildlife habitat.
- Watershed Rehabilitation Program Nebraska is a leader nationally in dollars received for watershed rehabilitation funding. Ten current projects are listed in the report.
- WRP Update Management of WRP easements continues to be a priority, but acceptance rates have dropped significantly since a new easement valuation process was implemented.
- Office Business Analysis NRCS in Nebraska has completed an analysis of workload by field
 office. This will likely result in closure of some small offices, but the primary aim is to
 improve efficiency and quality of services. Keith Rexroth commented that fewer offices
 make it more difficult for producers to get assistance.

DIRECTOR'S REPORT

Director Ann Bleed reported that drought conditions are expected to continue through the 2007 growing season. Global warming appears to be real based on data from the USGS and the National Oceanic & Atmospheric Administration (NOAA), and long-term projections reflect a

major decrease in stream flows. DNR is working closely with many NRDs to develop and implement Integrated Management Plans (IMPs). Work is in progress with Republican River Basin NRDs to revise IMP plans. The first Republican River Compact compliance report is due this summer, and Nebraska will be reporting that it exceeded allowed consumption during the period covered. John Burkholder asked about meeting on Thursday (with Republican River NRD) and what the time table plan is. Nebraska is to sign off with Kansas by the next compact meeting in August although it may not be in place.

Interrelated Water Management Plan Program Fund (IWMPPF) grant projects are getting underway and should generate a lot of exciting results. DNR has requested introduction of only two minor bills of a clean-up nature.

Bleed also introduced Brian Dunnigan as the agency's Deputy Director and noted that he is working diligently to improve work processes to make the department more efficient.

ENVIRONMENTAL TRUST

Bleed stated the Environmental Trust is gearing up for project reviews. Van Marter asked about two bills in the Legislature that would result in funding being taken away from the Environmental Trust. Bleed responded that the Governor is asking that Trust funds be used to help fund the water activities.

PLATTE AND REPUBLICAN RIVER ACTIVITIES

Bleed reported that another round of public meetings with the Republican NRDs has been initiated. The intent is to keep the public informed and provide an opportunity for input and that the state's goal is to try to stay in compliance.

WATER POLICY TASK FORCE

The next Water Policy Task Force meeting is scheduled for March 19 at the Cornhusker/Marriott. Bleed noted that the Task Force's focus is to detail out the specific funding needs for meeting requirements of LB962. These must be identified to justify the appropriation request. Clint Johannes added that funding requirements will be identified for both short- and long-term term plans.

LEGISLATIVE & BUDGET COMMITTEE

Keith Rexroth asked Ron Theis to report on legislation affecting the Commission. Theis handed out a summary of legislative bills, and he and other staff responded to questions.

Keith then asked Rex Gittins to comment on the budget. Gittins reported that the agency's budget request is consistent with the previous biennium budget, except that funding for buyout of Republican Basin irrigation districts' water resources was not requested. Bleed noted that the Water Resources Cash Fund which would be established by LB 322 would be a new responsibility for the agency and might involve some oversight by the Commission.

PROGRAM COMMITTEE

Clint Johannes reported that in the Program Committee which met at 11:00 a.m. status reports for all programs had been reviewed and discussed. He then reported on the following committee recommendations.

Nebraska Resources Development Fund (NRDF)

The Walnut Creek Lake and Recreation Area (Papio Dam Site 21) will be turned over to the City of Papillion later this year. The city has requested approval for a 2.56 acre portion in a low-use area of the project to be used for construction of a new fire station. Jim Cook described the Commission's options, noting that a fire station would not be consistent with the original intended purpose of the project.

Motion was made by Johannes and seconded by Watermeier that the City of Papillion be authorized to construct a fire station on a 2.56 acre portion, as described on the attached, of a land parcel purchased with assistance from the Resources Development Fund for the Walnut Creek Site 21 project, provided that such authorization is on the condition that the City first reimburse the Resources Development Fund in the amount of \$6,912.00, the portion of the original land parcel's purchase price that was provided from the Fund for that 2.56 acre portion. Motion carried.

The sponsor, Central Platte NRD, requested approval to combine the ten components previously approved into four. This change would more accurately reflect development sequence and facilitate the reimbursement request process.

Motion was made by Johannes and seconded by Korell to allow the ten previously approved components for the Upper Prairie/Silver/Moores Creek Project to be combined into four as follows: 1) Feasibility Study in the amount of \$138,862.50; 2) Land Acquision in the amount of \$364,273.87; and 4) Construction of all of cells No. 5, 7 and part of cell No. 4 in the amount of \$2,157,735.00. Motion carried.

Anderson reported on the initial meeting of a subcommittee formed to identify and recommend approaches for dealing with the situation where NRDF project applications exceed the Commission's authority to allocate funds under the cap. A survey was conducted to rank evaluation priorities of Commission members, NRD managers, irrigation district managers, and NRDF advisors, and preliminary results have been reviewed. Additional work is needed before recommendations can be made. The subcommittee will meet with DNR staff in February for further discussion and review.

Soil & Water Conservation Fund (SWCF)

The current SWCF rules do not allow for cost-share on conservation practices where federal support is being provided. Federal cost share is limited to fifty percent of the total cost, and landowners have often been unwilling to use the program. Ken Bernie from the Lower Elkhorn NRD stated that landowners would be more likely to use the federal program if SWCF cost-share on the landowner portion was available, and requested that the SWCF rules be amended accordingly. Jim Cook distributed and commented on a draft amendment which identified a SWCF cost-share of fifty percent of the landowner portion of costs. He noted that the Commission could modify the cost share and noted that a public hearing would be required.

Motion was made by Johannes and seconded by Madsen to accept the draft amendment to the Soil and Watershed Conservation Fund rules to allow cost-share on landowner share of federally-supported practices and to set up a hearing on proposed changes. Motion carried.

Brush Control is included as an approved practice for SWCF cost-share, but is presently limited to mechanical control. Prior to the meeting, Myron Lembke had asked that the issue of adding chemical as well as mechanical control be raised. Wayne Madsen stated support and further explained the need.

Motion was made by Wayne Davis and seconded by Hergott that the Soil and Water Conservation Fund Brush Control practice include both chemical and mechanical controls. Motion carried.
