ADVISOR REPORTS

NRCS

Kasey Taylor, Acting NRCS State Conservationist, distributed a report and gave a brief update on the NRCS budget and personnel training needs relating to NRD activities in the state. Other comments included:

- Resource assessment and work load review: projected financial assistance needs of \$38 million were identified.
- State technical assistance budget needs: the national office is evaluating options.
- Sequestration: if continued in FY14 and 15, additional cuts are likely.
- Compliance issues: staff is trying to help land owners make informed decisions before they break out land with sensitive soil issues.

ENVIRONMENTAL TRUST

No report given.

UNL WATER CENTER

Lorrie Benson was unable to attend but asked that the following items be mentioned.

- There are a few openings for the Water and Natural Resources Tour on June 25-27^h, 2013. This tour will look at water management issues in an area between Kearney, Columbus and just west of Lincoln.
- Dates have been set and final details are being worked out for the Water Symposium on October 15 and the Water Law Conference on October 16. Both will be at the Cornhusker Marriott Hotel in Lincoln.

DNR UPDATE

Gittins noted the DNR budget request was submitted with no change from the prior biennium but adjustments were made by the Legislature's Appropriations Committee in two areas. The Interrelated Water Management Plan Program Fund budget was reduced by \$150,000 for each of the next two years and funding will stop after the 2013-2015 biennium. The department's operating budget was increased by \$150,000 per year with a requirement that those funds be used only for a contract with UNL to gather and disseminate weather related data.

Soil and Water Conservation Fund Program

The Tri-Basin NRD had submitted a request that the Commission modify NSWCP Practice NC-3 and/or NC-19 to allow cost share for modification or decommissioning of dams constructed in violation State statutes. Hadenfeldt reported that the Program Committee had tabled a motion to modify Practice NC-3 pending further information from legal counsel.

Interrelated Water Management Plan Program Fund

No action. Due to a lower than anticipated funding level and uncertainty regarding projected needs for some projects, obligation of FY14 funding was deferred until the September Commission meeting. No significant impact on making reimbursements is anticipated, and the delay will allow staff and sponsors to work out a revised consensus for proposed allocations based on the reduced funding and more accurate projections of needs.

ANNOUNCEMENTS / OTHER BUSINESS

Staff discussed holding orientation sessions including policy review across the state. Due to anticipated schedule demands related to Commission members' participation on the Water Funding Task Force, no dates were set.

Donaldson requested that Commissioners set the 2014 meeting schedule at the September meeting to facilitate planning for personal activities. It was noted that the January and September meetings traditionally correspond with NARD conferences. Therefore, only the dates for the May/June meeting (usually out-state) and potentially a November/late fall meeting remain to be set. Miyoshi offered to host one of these meetings at the Lower Platte North NRD.

Edson announced that Pat O'Brien will become the next manager of the Upper Niobrara White NRD. Jennifer Swanson will replace O'Brien as the NARD liaison with DEQ. He also reported that Ron Cacek will be retiring later this year, and the North Platte NRD Board has selected John Berge to be the next manager for the North Platte NRD.

WATER FUNDING TASK FORCE (LB 517)

Senator Carlson briefed the Commission on his expectations for the Water Funding Task Force, created by LB 517 which he introduced. The senator discussed a tentative meeting schedule and stressed the importance of achieving sustainability of our water use to protect the resource for future generations.
